The Toronto and Region Conservation Authority (TRCA) is currently seeking a Director, Restoration and Infrastructure to provide leadership, expertise, management and overall strategic direction to the Restoration and Infrastructure division and perform a leadership role as a vital part of TRCA's senior leadership team. Reporting to the CEO, responsibilities include providing expert knowledge, direction and advice in the areas of capital asset management planning and infrastructure management and delivery, natural heritage management practices, principles related to civil and/or water resources engineering, resource information management, aquatic/terrestrial ecology, cultural heritage, construction practices, occupational health and safety and conservation land development and building science.

Additionally, the Director is responsible for leading the monitoring, assessment, design and implementation of all capital investment initiatives (built and green infrastructure); leading the development of the overall goals and objectives of TRCA as a member of the SLT, including implementing directions of the Strategic Plan, preparing multi-year Business Plans, annual and multi-year budget plans and funding models; pursuing new opportunities and joint ventures to develop state of the art financially sustainable programs, standards, and guidelines that can be applied within the Division and across the organization; representing TRCA at a wide range of forums including municipal councils, provincial committees, and hearing boards; creating and sustaining a network of TRCA staff and external professional experts for collaborative efforts; and, providing strong managerial, operational, organizational, communication, and client services skills. Additionally, this position is responsible for ensuring the work performed and completed by staff, contractors, and consultants adheres to all applicable TRCA, municipal, provincial and federal policies, guidelines and regulations/legislation.

Overall, this position plays an integral role in maintaining and enhancing TRCA's role as a leader in ecological restoration and enhancement, and risk management related to erosion and flooding.

The successful candidate will be passionate and energetic in the pursuit of TRCA's purpose with a proven track record as a leader who inspires, mentors, and develops team members. Additional **qualifications** include:

- A University degree in geotechnical/civil/water resource engineering, environmental sciences engineering, or landscape architecture; Master's degree in a related field considered an asset.

- PMP Certification.

- A minimum of fifteen (15) years' experience in environmental/civil/geotechnical engineering, design/construction management and implementation, and landscape architecture, including ten (10) years' progressively more challenging experience at a senior level in public and/or private sector operations.

- Experience in construction cost estimating and in asset (green and built) planning and infrastructure considered an asset.

- Demonstrated ability to lead public consultation, facilitate meetings and negotiate contentious issues by employing effective communication with stakeholder groups, Board members, politicians, and other partners.
